Use of Technology Release

Diablo Valley College Expanding Your Horizons conference must receive this release no later than 5 PM on Sept. 25 in order for your child to attend a workshop requiring computers/internet access.

In order to enrich your child’s conference experience, some of our workshops may be using software installed on computers or accessing the Internet. All of the computers are connected to the Diablo Valley College computer network which has access to the Internet.

Access to the Internet will enable your child to explore thousands of libraries, databases, and web sites containing information relevant to the workshop. While internet use in the workshop will be supervised by the workshop leader, your child may find ways to access other materials that may be potentially offensive. Diablo Valley College Expanding Your Horizons believes that the benefits to your child exceeds any disadvantages but does support and respect each family’s right to decide whether or not to allow their child access to the internet.

Diablo Valley College Internet Rules

Conference attendees are responsible for good behavior on Diablo Valley College’s computer networks just as they are in the classroom. Internet and computer access is provided for your child to conduct research and access learning materials to enhance her workshop experience.
